Terror incidents almost nil in J&K: Rajnath in LS

THE NUMBER of terrorist incidents has come down to almost nil in Jammu and Kashmir since the abrogation of provisions of Article 370 on August 5 and normalcy is being restored at a faster pace in the Valley, Defence Minister Rainath Singh told the Lok Sabha on Wednesday.

Meanwhile, in a written reply to a question in the Rajya Sabha, Minister of State (Home) G Kishen Reddy said the government had no record of any loss of income or jobs due to the decision taken by the government on August 5. "Due to these recent decisions, certain precautionary measures taken initially have already been substantially relaxed. There is no specific report received from the Government of Jammu and Kashmir regarding any new losses on account of such preventive steps taken as a short-term measure," Reddy said in a written reply to a question from CPM MP K Somprasad.

Somprasad had asked "whether government has noticed the burden, loss of income and jobs of people of Jammu and Kashmir following the restriction imposed in recent days".

Replying to another question, Reddy said the Centre had incurred no additional expenditure in Kashmir after August 5. TMC MP Shanta Chhetri had sought details of "increase of expenditure incurred by the government on the Union Territory of Jammu and Kashmir since the abrogation of Article 370".

In the Lok Sabha, responding to an issue raised by Congress MP Kodikunnil Suresh, Rajnath Singh said, "It is a fact that terrorist incidents have been happen-

ing in Jammu and Kashmir for last 30-35 years. I can say with confidence that after the abrogation of Article 370, the number of terrorist incidents has come down to almost nil (lagb-

hag na ke barabar)," Singh said. "As far as terrorist incidents are concerned, we all are aware that barring Jammu and Kashmir, no big terror incident has taken place in the last five-and-a-half years... If any terror incident has happened, obviously all of us will condemn, nobody will appreciate it. However, I can say that the Army, paramilitary forces as well as local police are mutually coordinating and taking effective actions against terrorist activities. I want to say that normalcy is being restored at a faster pace in Kashmir," he said.

Raising the issue during Zero Hour, Suresh alleged that the government is misleading the House on the situation in Jammu and Kashmir. "After the revocation of Article 370, this government is saying that Jammu and Kashmir is gradually returning to normalcy but it is not correct," Suresh said. Referring to the militant attacks in Anantnag district on Tuesday, he said, "What happened yesterday?... One government officer and one sarpanch were killed. Six others were injured in the cruel attack... Government is misleading the House."

Lok Sabha Speaker Om Birla intervened and asked him what his demand was. "Every day, terrorist attacks are taking place... Where is normalcy in Jammu and Kashmir? Minister of Home Affairs should come and make a statement on this issue," Suresh said.

Congress leader Adhir Ranjan Chowdhury raised the issue of Internet services in the Valley. National Conference MP Hasnain Masoodi raised the same issue during Question Hour.

Chidambaram: If bail denied over 'gravity' of allegations, all undertrials would be in jail

FORMER UNION minister P Chidambaram on Thursday told the Supreme Court that the High Court had denied him bail in the INX Media money-laundering case registered by the ED on the ground of "gravity" of the allegations and that going by this argument, no undertrial would ever

Appearing for Chidambaram, senior advocate Abhishek Manu Singhvi told a bench of Justices R Banumathi, A S Bopanna and Hrishikesh Roy that after "satisfying" that he was not a flight risk or likely to tamper with evidence or influence witnesses, "the word gravity is used to negative all this".

"If this is accepted, all undertrials will be incarcerated till trial ends in almost every case," he said. "Once the attendance (for trial) is secured, bail cannot be denied except in extraordinary situations like in the case of a terrorist or a repeated or habitual offender," Singhvi said. "Gravity will

remain till end of trial. By that logic, I should be in jail till trial ends. There is no other way and that would be a ridiculous conclusion."

The senior counsel said that Thursday was the 99th day of incarceration for Chidambaram. Giving bail to the accused would also help them defend themselves

better during trial, he contended. Senior counsel Kapil Sibal, also appearing for Chidambaram, said that though the witnesses were available since 2018, the ED had not cared interrogated him. The idea was only to keep him in cus-

Google: Nearly India warned of phishing attacks

GOOGLE SENT out more than 12,000 warnings to users globally, including nearly 500 in India, between July and September this year to sound them out against being targeted by "governmentbacked attackers".

The report does not specify whether the attacks are by governments on their own citizens, or on other countries' citizens.

The vast majority of the warnings involved "credential phishingemails" that attempt to access a user's credentials such as passwords. An example is an email masquerading as a mail from Google that asks the user to enter her/his password. Some concerted campaigns in this regard have been discovered in Russia and South Korea, Google stated.

The development comes days after another social media giant, WhatsApp, stated that an Israeli spyware called Pegasus had been used to spy on journalists and human rights activists worldwide, including 121 people in India.

The NSO Group, which owns Pegasus, maintains that it sells to governments. In a blog, Google's Shane Huntley stated the company's Threat Analytics Group tracks "more than 270 targeted or government-backed groups from more than 50 countries". These groups have many goals, "including intelligence collection, stealing intellectual property, targeting dissidents and activists, destructive cyber attacks, or spreading coordinated disinformation", according to the company.

SC reserves order on J&K curbs

New Delhi: The Supreme Court has reserved its order on petitions challenging the restrictions imposed in Jammu and Kashmir in the wake of scrapping of special status, with a three-judge bench observing that it "will have to balance" the arguments of the petitioners and respondents. The remarks came as Sibal questioned the figures submitted by the I&K administration about the number of people accessing hospitals and internet booths, number of public vehicles on roads, etc. to back its claim that normalcy was returning to the region. **ENS** epaper indianexpress.com

The money-laundering case is

an offshoot of the graft case registered by the CBI. Sibal contended that many of the findings in the HC order were the same as the ED's submissions in its counter affidavit. He wondered "how counter affidavit becomes finding" of court and "what kind of judicial process this is". "Not one email... not one SMS from me or to me has been found... not one document has been traced to me," Sibal said adding that while all coaccused have been granted bail, he was still in jail on the ground of "gravity" of allegations that were accepted as gospel truth.




